Current Gallery invites video artists and enthusiasts to submit videos of all genres (experimental, animation, music video, documentary, short, home video, outtakes, unfinished films, scientific studies, etc). Works selected from this call will be featured in baltimore vs. the world DVD publication due out 2009.

baltimore vs. the world is a DVD publication released through Current Gallery. It will incorporate two separate DVD compilations. One DVD will feature selected works from around the world and the other DVD will focus on selected works from Baltimore, Maryland. Accompanying the DVDs will be a booklet with interviews and support materials.

Eligibility:

- Entries by individuals, groups, collectives or organizations are accepted.
- Video(s) must be complete at time of submission.
- One to Five Videos per entry.
- Entries not to exceed one hour in total running time.
- No single video may exceed 30 minutes in length.

Application Packet should include the following:

- Completed entry form
- A brief description or synopsis of your video(s) not to exceed 250 words per video
- Resume (optional)
- Bio not to exceed 150 words
- Label each DVD with artist name(s), title of video, and total running time.
- \$5 application fee (no cash) **All checks or money orders made payable to Current, LLC**
Application fee will be waived for international applicants to offset shipping costs

Formats:

Two (or more if needed) DVDs are required:

- (This is IMPORTANT for us to compile with other artist's videos for final DVD publication)
- First DVD - Complete video compilation, 1-5 video(s)
- Second DVD - Two separate files per video: mpeg2 and aiff or wav (for sound)
- Foreign language work must be subtitled in English
- Please email us if you have trouble with formatting currentspace@gmail.com

Notification:

- Submissions will be selected by Current Gallery's Co-Directors.
- If your entry is selected for publication and/or exhibition you will be notified late November 2008.
- No application materials will be returned (please do not send us your original copy).
